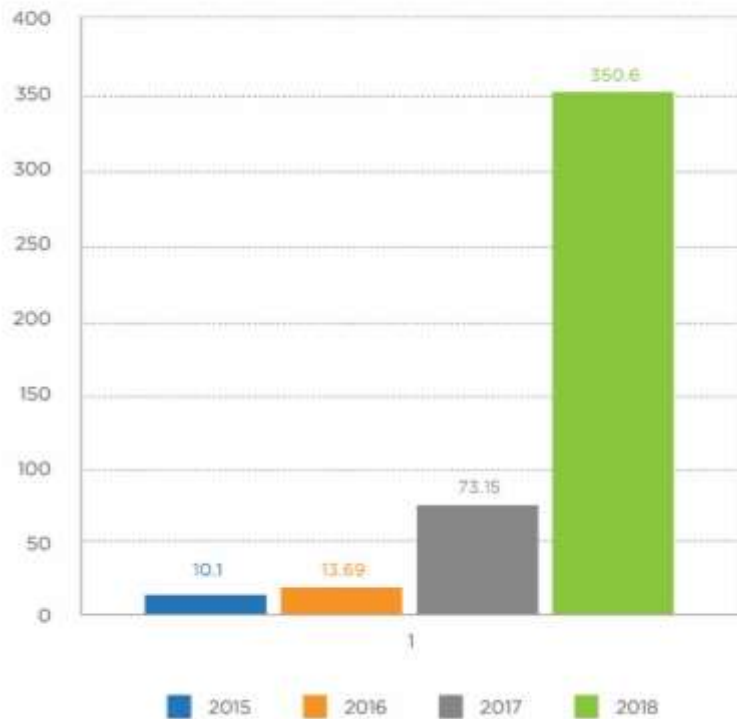

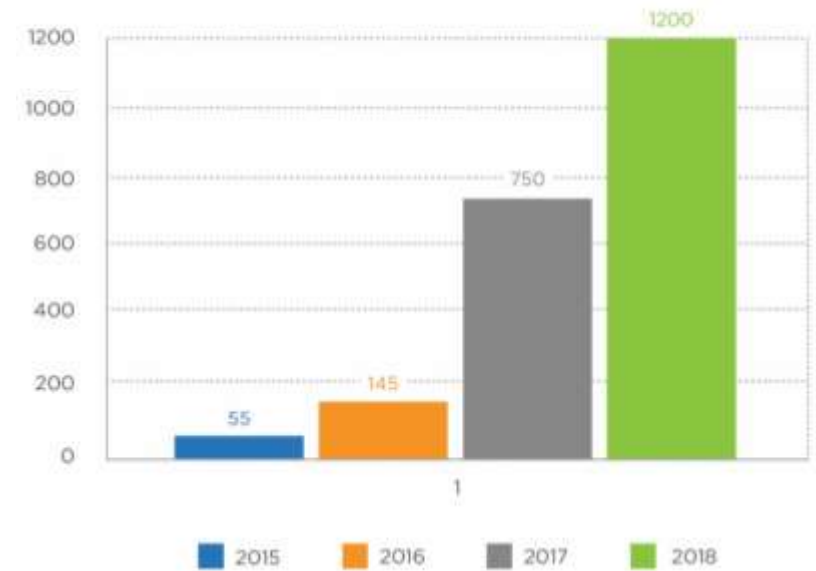
## Annual Revenue

PGK million



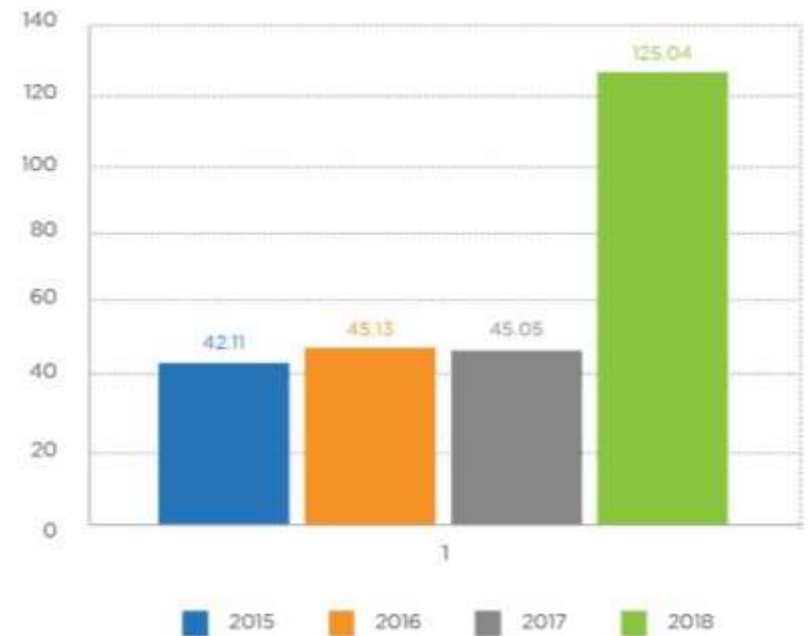
## Workforce
